Our theme is used for staging the show, but not intended to limit entries. Wearable Art is handcrafted, one-of-a-kind artwork designed to be worn by the human body.

If selected to be in the Gala performances, it is MANDATORY that your entry be in all 3 Gala performances, as well as the Saturday Matinee (unless deemed inappropriate for young audiences by KAAHC)!

Criteria:

- Pieces cannot exceed 2:00 minutes in length.
- School groups must provide a models for group pieces. Individual student artists must either model their piece or provide a model.
- A photographer will document the event for the Arts Council. It is the responsibility of the artist to inform models that photos may be used in publicizing the Wearable Art Show and the Arts Council. Models will be required to sign a release form.
- Wearable art must be handcrafted from "scratch". No ready-made costumes.
- KAAHC reserves the right to exclude work that is incomplete or inappropriate for the show.
- **DRESS REHEARSAL:**
Attendance is mandatory for all Group members, individual students, & models. Models must be dressed in the Wearable art piece or have it to show the committee.

Tips:

- Look at your piece from all angles. The audience will have a 360-degree view, and will be sitting lower than the runway, (pay attention to how your piece looks from below).
- All visible apparel should be intentional and pertain to the piece being presented. For example, regular street clothes are not appropriate to set off a beautifully crafted papier-mache hat.
- Consider how your piece will "read" from across a large room. Fine detail may be lost at a distance.
- Because of the limited space backstage, we ask that you check with us in advance if your piece is larger than a standard doorframe. There is limited space for larger pieces.
- **The Ted Ferry Civic Center forbids the use of glitter. Find an alternative!!!**
- In selecting your music, consider how movement can enhance the piece, and what music suits the mood of the piece – that is usually more important than the lyrics of the music. Continuity of music is important in the staging of the show, and the final decisions about music selections will be made by the musical directors.

The artists involved in the Wearable Art Show have made the event a well-loved tradition! The KAAHC's Wearable Art Committee brings all the creations together to present the audience with an exquisite evening of art and entertainment, using the theme, music, staging, and narration to tie everything together. In consideration of the event as a whole, the Committee is responsible for final decisions regarding narration, music, and staging, as well as the order and inclusion in the program.

WEARABLE ART SHOW ARTIST APPLICATION

GROUP is defined by who is participating in a single song (or 2-minute-or-less runway performance if music is edited). Multiple songs = multiple Groups.
One application should be completed for each Group.
